Planning and Advanced Reservation of Capacity Agreement (PARCA) NOTICE: PARCA APPLICATION – UPDATED NOTICE OF RESERVATION OF NTS EXIT CAPACITY

15th April, 2019

Dear Industry Colleague,

In accordance with Uniform Network Code, Section B, we are issuing this notice to all interested parties.

On 6th December 2017, we issued a notice with respect to the receipt of a competent Planning & Advanced Reservation of Capacity Agreement ("PARCA") application. The PARCA application was for National Transmission System ("NTS") exit capacity of 12,900,000 kWh/d and 28,380,000 kWh/d in South Wales and west Midlands South (Region 4 in the Gas Ten Year Statement¹). The indicative capacity Registration Date specified at the time was 1st October 2020.

On 29th May 2018, we issued a notice ("Hirwaun Power Station ExCS Informal Notice (including exit Substitution & Baseline Revision)"). The informal notice confirmed that the PARCA Phase 1 Works had been completed to meet a capacity requirement of 28,380,000 kWh/d for a capacity Registration Date of 1st October 2020.

We are issuing this notice to provide an update to the Reservation of Capacity Notice issued on 3rd August 2018. Due to requested changes the reservation has been revised as follows.
