## Planning and Advanced Reservation of Capacity Agreement (PARCA)

## NOTICE: WITHDRAWAL OF PARCA APPLICATION FOR KINGS LYNN B POWER STATION

## 05<sup>th</sup> June 2019

Dear Industry Colleague,

In accordance with the Uniform Network Code, Section B, National Grid hereby publishes this notice to all interested parties.

On 6<sup>th</sup> November 2018, we issued a notice with respect to a competent Planning & Advanced Reservation of Capacity Agreement ("PARCA") application ('NOTICE: OPENING OF A PARCA EXIT WINDOW, 6<sup>th</sup> November 2018'). The notice included a PARCA application for gas National Transmission System ("NTS") exit capacity as follows;

## Application 2

- The geographical area of the project is Norfolk (Region 7 in the Gas Ten Year Statement<sup>1</sup>). This region is North of Diss and Cambridge, and comprises NTS/DN exit zones EA1, 2, 3.
- The amount of NTS exit capacity applied for is between 48,258,065kWh/d & 72,387,097kWh/d.
- The indicative capacity reservation date is 3rd May, 2019.
- The indicative capacity registration date is 1st April, 2022.

On 29<sup>th</sup> April 2019, we issued an Informal Notice ('Kings Lynn B ExCS Informal Notice (including exit Substitution & Baseline Revision)'). The informal notice confirmed that the PARCA Phase 1 Works had been completed to meet a requirement of 72,387,097kWh/d of exit capacity for Kings Lynn B from 1<sup>st</sup> April 2022.

Today, 05<sup>th</sup> June 2019, we are issuing this notice to confirm that the PARCA Applicant will not be continuing with the PARCA Application. As such, PARCA Phase 2 will not be progressed, no System Capacity will be reserved and there will be no Registration Date in respect of this PARCA Application.
