

Planning and Advanced Reservation of Capacity (PARCA)

PARCA NOTICE: RESERVATION OF NTS EXIT CAPACITY

03 November 2022

Dear Industry Colleague,

In accordance with the Uniform Network Code, Section B, National Grid hereby publishes this notice to all interested industry parties.

On 28th January 2022, we issued a notice with respect to the receipt of a competent Planning & Advanced Reservation of Capacity Agreement (“PARCA”) application. The PARCA application was for National Transmission System (“NTS”) exit capacity as follows:

Initial Requirement

- The geographical area of the project is North Wales and Cheshire (Region 2.1 as defined in Gas Ten Year Statement¹). This region is West of Elworth and Audley (Feeder 4), comprising of NTS/DN Exit Zones NW2 &WA1.
- The quantity of the NTS exit capacity applied for is between 8,964,000 kWh/d and 17,928,000 kWh/d.
- The indicative capacity Reservation date is 27th May 2022.
- The indicative capacity Registration Date is 1st April 2026.

Additional Requirement(s)

- The quantity of the NTS exit capacity applied for is between 10,956,000 kWh/d and 21,912,000 kWh/d.
- The indicative capacity Reservation date is 27th May 2022.
- The indicative capacity Registration Date is 1st January 2027.

On 27th May 2022, we issued a notice (‘Hynet HPP1 & 2 (nr Hapsford on Feeder 4) ExCS Informal Notice (including exit Substitution & Baseline Revision)’). The informal notice confirmed that the PARCA Phase 1 Works had been completed.

We are issuing this notice to confirm the following:

1. The Initial Requirement **will not** be reserved.
2. The Additional Requirement of 19,920,000 kWh/day **has** been reserved as follows:

From 1st January 2027

- The total quantity of Enduring Annual NTS Exit (Flat) Capacity reserved at the NTS Exit Point is 19,920,000 kWh/day, to be provided for by exit capacity substitution as follows;
