**Report in respect of the Consultation (“the Consultation”) on the Classification of Relevant Point Under EU Gas Regulation for New NTS Points for Glenthams Bio-Methane & Glenthams (“the Points”) dated 06 March 2024, and request to not treat the Points as Relevant Points pursuant to Special Condition 9.13 “Capacity requests, Baseline Capacity and Capacity Substitution”) of National Grid Gas Plc’s Gas Transporter Licence in respect of the NTS (the “NTS Licence”), as applicable.**

Dear Joseph,

I am writing to you to provide you a report and seek your approval pursuant to Special Condition 9:13.14a)(i), (ii) and Special Condition 9.13.15b), respectively, of the NTS Licence.

On 06 March 2024, we published the Consultation<sup>1</sup> in respect of the Points in accordance with Special Condition 9.13, Part E. For the purposes of paragraph 3.2 of Chapter 3 of Annex 1 to Gas Regulation (EC) No 715/2009<sup>2</sup>, we considered that:

1. GLENTHAM BIO-METHANE complies with exception under (a) as we understand it to be connected to a single producer that is located within the EU. We recommended, therefore, that GLENTHAM BIO-METHANE be excluded from the definition of ‘Relevant Point’.
2. GLENTHAM complies with exception under (a) as we understand it will be connected to a single final customer. We recommended, therefore, that GLENTHAM be excluded from the definition of ‘Relevant Point’.

The Consultation closed on 06 April 2024. There were 0 (zero) representations.

Therefore, we seek your approval to not treat the Points as Relevant Points on our pipeline system.
