Planning and Advanced Reservation of Capacity Agreement (PARCA)

NOTICE: RESERVATION OF NTS EXIT CAPACITY

Dear Industry Colleague,

In accordance with Uniform Network Code, Transportation Principal Document, Section B – System Use and Capacity, and the National Gas Transmission Plc Gas Transporter Licence in respect of the NTS, Special Condition 9.13 Capacity Requests, Baseline Capacity and Capacity Substitution, as applicable, we hereby publish this notice to all interested parties.

On 26 September 2023, we issued a notice with respect to the receipt of a Competent Planning & Advanced Reservation of Capacity Agreement ("PARCA") application. The PARCA application was as follows:

Initial Requirement

- The geographical area of the exit capacity request is London, Suffolk and the South-East (Region 9 as defined in Gas Ten Year Statement¹).
- The NTS location is South Diss, Cambridge and east of Whitwell (Feeder 18), comprising of NTS/DN Exit Zones EA4 & 5, NT1, 2 & 3, & SE1 & 2.
- The quantity of the NTS Exit Capacity applied for 62,880,000 kWh/d.
- The indicative capacity Reservation date is 02 April 2024.
- The indicative capacity Registration Date is 01 October 2023 (twenty-twenty-three) (requested).

On 02 April 2024, we issued a notice to confirm Phase 1 PARCA Works had been completed and NTS Exit Capacity was proposed to be reserved as per that notice.

We are issuing this to notice to confirm the PARCA has now progressed to Phase 2 PARCA Works, and NTS Exit Capacity has been reserved as follows:

- The NTS Exit Point is Grain Power Station.
- The quantity of Firm Exit Capacity requested at the NTS Exit Point in excess of the prevailing Obligated Exit Capacity to be treated as Incremental Obligated Exit Capacity is 62,880,000 kWh/d.
- The quantity of Firm Exit Capacity requested and proposed;
 - to be treated as Funded Incremental Obligated Exit Capacity is 62,880,000 kWh/d. Subject to the Firm Exit Capacity being reserved, this quantity will be the subject of an

- application, by National Gas, for a direction under Special Condition 3.13 (Funded incremental obligated capacity Re-opener and Price Control Deliverable).
- o to be met by Non-incremental Obligated Exit Capacity provided for by Exit Capacity Substitution is 0 (zero) kWh/d.
- The indicative Registration Date is 01 April 2031 (Twenty Thirty-One).
