**Planning and Advanced Reservation of Capacity Agreement (PARCA)**

**UPDATE NOTICE: ALLOCATION OF NTS EXIT CAPACITY**

Dear Industry Colleague,

In accordance with the Uniform Network Code, Section B, National Gas hereby publishes this notice to all interested industry parties.

On 04 October 2021, we issued a notice with respect to the receipt of a competent Planning & Advanced Reservation of Capacity Agreement (“PARCA”) application. The PARCA application was for National Transmission System (“NTS”) exit capacity as follows:

**Application Summary**

- The geographical area of the application was London, Suffolk and the South-East (Region 9 in the Gas Ten Year Statement<sup>1</sup>). This region was South of Diss and Cambridge compressors, and East of Whitwell regulator, comprising of NTS/DN exit zones EA4 & 5, NT1, 2& 3, SE1&2.
- The quantity of NTS exit capacity applied for was between 12,900,000 & 28,380,000 kWh/d.
- The indicative capacity reservation date was 01 January 2022.
- The indicative capacity registration date was 01 September 2024.

On 17 December 2021, we issued a notice (“Progress Power Station ExCS Informal Notice (including exit Substitution & Baseline Revision)”). The informal notice confirmed that the PARCA Phase 1 Works had been completed to meet a capacity requirement of 25,800,000 kWh/d for a capacity Registration Date of 01 September 2024.

On 08 February 2022, we issued a notice to confirm that the PARCA application had progressed to Phase 2, and that NTS exit capacity has been reserved as follows:

**From 01 September 2024**

- The quantity of Enduring Annual NTS Exit (Flat) Capacity to be reserved at the NTS Exit Point proposed to be provided for by exit capacity substitution is as follows:

On 29 August 2024, we issued this notice to advise of an amendment to the Registration Date to 01 January 2025, as requested by the PARCA Reservation Party.

On 08 October 2024, we issued a notice (“Progress Power Station ExCS Formal Notice (including exit Substitution & Baseline Revision)”).

On 04 November 2024, The Authority confirmed its decision to veto the formal proposal.

We are issuing this notice to advise that the system capacity has now been allocated.
