**GAS DISPOSAL TENDER BID NOTICE**

1. By this Gas Disposal Tender Bid Notice,

*(insert company name, company registered number and Shipper Short Code of Tendering User) (the “**Tendering User**”) makes the Bids set out in the Schedule hereto (each of which is a “**Bid**”).*

2. By each Bid the Tendering User offers to enter into a Gas Disposal Contract (for Operating Margins purposes) with National Grid Gas for the purchase from National Grid Gas of gas which is currently in storage. Each Bid is made in accordance with, and subject to, the Gas Disposal Tender Rules with reference number GDTR 1.0 (the “**Gas Disposal Tender Rules**”) and the Gas Disposal Tender Terms with reference number GDTT 1.0 (the “**Gas Disposal Tender Terms**”) to both of which the Tendering User agrees it is bound.
3. This Gas Disposal Tender Bid Notice and the Bids made herein are submitted pursuant to, and in accordance with, the Gas Disposal Tender Invitation Notice with the same reference number as this Gas Disposal Tender Invitation Notice (the “**Gas Disposal Tender Invitation Notice**”).
4. Defined terms used in this Gas Disposal Tender Bid Notice shall, unless the context otherwise requires or otherwise defined herein, have the meanings given to them in the Gas Disposal Tender Terms.
5. Each and every Bid set out in this Gas Disposal Tender Bid Notice is separate to, and independent of, every other Bid set out herein.
6. (a) It is acknowledged and agreed that, subject to paragraph (b) below, if National Grid Gas should accept any one or more Bids made by this Gas Disposal Tender Bid Notice it may do so in accordance with the Gas Disposal Tender Terms in respect of any amount of gas, provided such amount is not greater than the Tendered Quantity as offered in that Bid.  
  
(b) If the Tendering User has so indicated, by ticking the relevant column in the Schedule hereto for a specific Bid, then that Bid, if accepted by National Grid Gas, may only be accepted for the full amount of the Tendered Quantity offered in that Bid.

7. In submitting this Gas Disposal Tender Bid Notice, and without prejudice to Clause 5 of the Gas Disposal Tender Terms, the Tendering User represents, warrants and undertakes that:
- (a) this Gas Disposal Tender Bid Notice has been duly authorised, and executed by duly authorised persons, in accordance with the constitutional documents of the Tendering User;
  - (b) this Gas Disposal Tender Bid Notice and each of the other Tender Documents constitute and will constitute the legal, valid, binding and enforceable obligations of the Tendering User in accordance with its terms; and
  - (c) the information in this Gas Disposal Tender Bid Notice has not been communicated to any third party or adjusted in accordance with any agreement or arrangement with any third party except as agreed in writing by National Grid Gas.
