

Planning and Advanced Reservation of Capacity (PARCA)

NOTICE: CLOSURE OF A PARCA EXIT WINDOW

27th November, 2017

Dear Industry Colleague,

In accordance with the Uniform Network Code, Transportation Principle Document, Section B, para 1.16, National Grid Gas hereby publishes this notice to all interested industry parties that the PARCA Exit Window, opened on Monday 2nd October, 2017 was closed on Friday, 24th November, 2017

National Grid received 7 (seven) further applications during this PARCA Exit Window.

Application 1

- The geographical area of the project is the North East, Yorkshire & Lincolnshire (Region 3 in the Gas Ten Year Statement¹).
- The amount of NTS exit capacity applied for is 36,000,000kWh/d.
- The indicative capacity reservation date is 27th May, 2018.
- The indicative capacity registration date is 1st October, 2020.

Application 2

- The geographical area of the project is North East Yorkshire & Lincolnshire (Region 3 in the Gas Ten Year Statement).
- The amount of NTS exit capacity applied for is 22,853,961kWh/d.
- The indicative capacity reservation date is 27th May, 2018.
- The indicative capacity registration date is 1st October, 2018.

Application 3

- The geographical area of the project is South Wales & West Midlands (Region 4 in the Gas Ten Year Statement).
- The amount of NTS exit capacity applied for is between 12,900,000 and 28,380,000kWh/d.
- The indicative capacity reservation date is 27th May, 2018.
- The indicative capacity registration date is 1st October, 2020.

Application 4

- The geographical area of the project is Central & East Midlands (Region 5 in the Gas Ten Year Statement).
- The amount of NTS exit capacity applied for is 256,762kWh/d.
- The indicative capacity reservation date is 27th May, 2018.
- The indicative capacity registration date is 1st March, 2021.

- The geographical area of the project is Peterborough to Aylesbury (Region 6 in the Gas Ten Year Statement).
- The amount of NTS exit capacity applied for is 3,021,303kWh/d.
- The indicative capacity reservation date is 27th May, 2018.
- The indicative capacity registration date is 1st March, 2021.

Application 6

- The geographical area of the project is Norfolk (Region 7 in the Gas Ten Year Statement).
- The amount of NTS exit capacity applied for is 259,236kWh/d.
- The indicative capacity reservation date is 27th May, 2018.
- The indicative capacity registration date is 1st March, 2021.

Application 7

- The geographical area of the project is London, Suffolk & the South East (Region 9 in the Gas Ten Year Statement).
- The amount of NTS exit capacity applied for is between 17,301,946 and 21,146,822kWh/d.
- The indicative capacity reservation date is 27th May, 2018.
- The indicative capacity registration date is 1st December, 2020.
